### HISTORY AND FOUNDATION

The roots of Freemasonry in Kazakhstan date back to 1904, linked with our first Kazakh Freemason and Prime Minister, Alikhan Bokeikhan, and other legendary brothers from the "Alash" and "Jadidchilar" movements. During the Soviet era, Masonic lodges were banned. Only in 2015 did Freemasonry return and begin to revive in our country.

On November 12, 2016, with the support of the Grand Lodge of Russia and delegations from the Grand Lodges of Austria, Georgia, Greece, Moldova, and Turkey, the QAZAQ JOĞARY LOJASY was formally established in Almaty. For the first time in history, Kazakhstan had its own independent and sovereign Masonic jurisdiction.

### CONSTITUTION OF THE GRAND LODGE OF KAZAKHSTAN

Adopted on 12.11.2016 in Almaty.

#### Key elements include:

- Sovereignty of the Grand Lodge within the Republic of Kazakhstan
- Full independence and commitment to the universal Masonic tradition
- Organizational rules for founding and managing lodges
- Moral and ethical obligations of Masons
- Prohibition of dual membership with irregular Masonic bodies












## HISTORICAL TIMELINE OF THE DEVELOPMENT OF THE GRAND LODGE OF KAZAKHSTAN
